## TRADE NOTICE

### **Sub: Waiver in Port storage charges for the period of External Transport Strike**

In response to the request from the trade for a consideration on the storage charges for the period of the external transporter strike, DP World Cochin would like to inform the trade that the external transport strike by the customer's transporters has resulted in operational challenges, increased costs, and loss of revenue for DP World. However, as a matter of goodwill and in order to assist the trade to recover from this difficult period we are proposing to extend a 50% discount on the Port storage tariff for the period of the external transporter strike as below.

- Import containers (Exim/Coastal/Laden/Empty) discharged during the period 29<sup>th</sup> January 2019 to 07<sup>th</sup> February 2019 only will be eligible for the 50% discount from the tariff on the days from 3<sup>rd</sup> Feb to 8<sup>th</sup> Feb.
- This will be applicable only if the subject containers are gated out of the terminal on or before 24:00 hrs of 15<sup>th</sup> February 2019.
- Containers which are not gated out of the terminal on or before 15<sup>th</sup> Feb will not be eligible for above waiver and Port storage charges at tariff as per TAMP SOR will be applicable.
- The waivers on eligible containers will be granted automatically without requiring the shipping line to apply through our CRM by way of Credit Notes within 3 working days of the invoice date.
